6. INFORMATION AND DISCUSSION

6.1 Results of the El Dorado County Office of Education 2018-19 First Interim Review

EXPLANATION: The results of El Dorado County Office of Education 2018-19 First Interim Review will be shared with the Board of Trustees.

BACKGROUND: In compliance with the provisions of Education Code Section 42130 et seq., the El Dorado County Office of Education has completed its review of our District's 2018-19 First Interim budget which was approved by the Board of Trustees at the December 13, 2018 Board Meeting. This review covers the 2018-19 First Interim Budget as well as the projections for 2019-20 and 2020-21. The County Office is required to issue a letter to the Governing Board by January 15, 2019, that indicates agreement (or disagreement) with the District's

finding of positive, qualified or negative budget.

Discussion:

Sid Albaugh, CBO, shared that the El Dorado County Office of Education has issues a letter to the Board of Trustees accepting the District's positive certification.

6.2 Get Real Results

EXPLANATION: Kim Taylor, Drug Free Divide Youth Coordinator, will share information gathered from the Get Real event.

BACKGROUND: Georgetown Rotary Club partners with Drug Free Divide to host a two day event for 7th and 8th graders. The focus is on helping kids to break down barriers and realize that everyone has things to overcome and all should be kind and compassionate towards each other. One day is dedicated to 7th graders and one day is dedicated to 8th graders.

Discussion:

Carolyn Barla and Kim Taylor, Drug Free Divide Youth Coordinator, shared information from the two program that was developed to empower students to take an active role in changing the culture in school to create a safe and positive environment. At the end of both sessions, kids were asked to answer two questions: 1) what is something that is positive in your life/works well in your life and 2) if you really knew me, you would know that.... the answers were written on sticky notes and put in to large pieces of paper and shared with the Board. All notes are anonymous, but brought up some concerns. The concerns caused for deepers discussions and promises to do and be better and make better choices. Get Real inspires and encourages all of these positive changes.

6.3 California State Dashboard Assessment Report #2

EXPLANATION: Site administrator will present site results from the California State Dashboard.

BACKGROUND: California's accountability system is based on multiple measures that assess how local educational agencies (LEAs) and schools are meeting the needs of their students. Performance on these measures is reported on the California School Dashboard. The Dashboard contains reports that display the performance of local educational agencies (LEAs), schools, and student groups on a set of state and local measures to assist in identifying strengths, weaknesses, and areas in need of improvement.

Discussion:

Superintendent Meyers opened with recount of presentation given last month on the Dashboard and the way the SBAC testing reflects on the Dashboard and student acheivment along with other local indicators. Wendy Westsmith went into a deeper discussion on the Dashboard and how its providing information for Georgetown School. Carrie Arnett looked at Northside Schools dashboard and Ron Morris discussed Golden Sierra Junior Senior High School's dashboard. Jeremy Meyers discussed how the dashboard results help drive the LCAP.

6.4 CSBA Board Policy Updates

EXPLANATION: The Board of Trustees will review the following CSBA updated/revised Board Policies and/or

Bylaws:

BACKGROUND: BP 4161.3 - BP added; AR 4161.3 deleted. Regulation deleted and moved to new policy since the responsibility for granting professional leaves rests with the board pursuant to law. Policy reorganized for clarity, revised to more directly reflect law, and expanded to add board philosophical statement and an exception in law allowing a professional leave under an approved national recognized fellowship or foundation to be included in computing the service requirement for a subsequent leave.

BP 4261.3 - BP added; AR 4261.3 deleted. Regulation deleted and moved to new policy since the responsibility for granting professional leaves rests with the board pursuant to law. Policy reorganized for clarity, revised to more directly reflect law, and expanded to add board philosophical statement.

BP 5112.5 - BP revised; AR 5112.5 deleted). Policy revised to clarify options for open campus and add optional language regarding district criteria for student eligibility for open campus privileges. Policy also includes the requirement for written parental notification of the open campus policy, formerly in AR, and clarifies that a student's unauthorized absence from school constitutes an unexcused absence but is not classified as truancy unless it meets the legal definition of truancy based on the number of absences during the school year. Regulation deleted and key concepts moved to BP.

BP 6174 - BP/AR revised. Policy and regulation updated to reflect NEW STATE REGULATIONS (Register 2018, No. 20) governing the implementation of Proposition 58 requirements pertaining to language acquisition programs, and to delete references to the former state assessment of English proficiency. Policy also adds concepts recommended in NEW CDE PUBLICATION (The California English Learner Roadmap: Strengthening Comprehensive Educational Policies, Programs and Practices for English Learners). Regulation adds definitions of designated and integrated English language development, renumbers cites to state regulations related to testing accommodations pursuant to NEW STATE REGULATIONS (Register 2018, No. 4), and reflects NEW LAW (AB 81, 2017) which requires specified information related to "long-term English learners" or "students at risk of becoming a long-term English learner" to be included in the Title I or Title III parental notification of a student's assessment of English proficiency.

7.2 ACTION: Local Education Accountability Plan (LEAP)

RECOMMENDATION: It is recommended that the Board of Trustees consider taking action to approve the Local Education Agency Plan Annual Review/Update.

BACKGROUND: The No Child Left Behind (NCLB) Act of 2001 mandates local education agencies to develop a Local Education Agency Plan (LEAP) as a requirement for receiving federal funding. The plan describes the actions Districts will take to ensure that programmatic requirements are met. The LEAP is a single, coordinated,

and comprehensive plan describing services for all students. The LEAP was intended as a five-year plan, operational from July 1, 2003 through June 30, 2008; it must, however, be annually reviewed and updated with consultation of local advisory groups, including school site councils and the District Advisory Council. Since NCLB has not yet been reauthorized, we are continuing to annually update our LEAP at least until that authorization takes place and we are given new requirements.

7.3 ACTION: Low-Performing Student Block Grant for BOMUSD and American River Charter School

RECOMMENDATION: It is recommended that the Board of Trustees consider taking action to approve the Low Performing Student Block Grant Plan for the Black Oak Mine Unified School District and the American River Charter School, as presented.

BACKGROUND: Pursuant to Education Code 51570 (d) the Low Performing Student Block Grant (LPSBG) provides funds for local educational agencies (LEAs) serving students identified as low-performing on state English language arts or mathematics assessments, who are not otherwise identified for supplemental grant funding under the Local Control Funding Formula (LCFF), or eligible for special education services.

LEA's are required to adopt a plan and submit the required information to the CDE on or before March 1, 2019. The Black Oak Mine Unified School District will receive \$154,130 and the American River Charter School will receive \$23,712 for participating in the Low Performing Student Block Grant.

9.5 CSBA Board Policies Second Reading and Adoption

RECOMMENDATION: It is recommended that the Board of Trustees consider adopting the updated/revised CSBA Board Policies.

BACKGROUND: BP 0415 Equity - New policy addresses the district's recognition and response to the unique barriers facing historically underserved and underrepresented student populations. Policy expresses the district's intent to proactively identify class and cultural biases as well as practices that impede equal access to opportunities for all students. Policy also presents examples of strategies to promote equity in district programs and activities.

BP 1400 Relations Between Other Governmental Agencies and the Schools - Policy revised to delete material regarding the use of school facilities as a polling place, now addressed in BP 1330 - Use of School Facilities. Policy adds material on collaboration with local government agencies, formerly in BP 1020 - Youth Services.

BP 2210 Administrative Discretion Regarding Board Policy - Policy updated to add the board's expectation that the superintendent or designee will be nondiscriminatory and demonstrate a commitment to equity whenever he/she is exercising administrative authority to address a situation that is either not covered in written policies or that requires immediate action to avoid risk to student and staff safety, protect district property, or prevent disruption of school operations. Policy clarifies the superintendent's accountability for all areas of operation under his/her authority and provides that the superintendent or designee will notify the board, as appropriate, of his/her

actions exercised pursuant to this policy.

BP 3312.2 Educational Travel Program Contracts - Updated policy clarifies the board's responsibility to approve contracts for educational travel programs and adds contract components, formerly in AR. Regulation deleted and key concepts moved to BP.

BP 3320 Claims and Actions Against the District - Policy and regulation updated to clarify the applicability of the Government Claims Act to certain claims for money or damages against the district, and to reflect NEW COURT DECISION (Big Oak Flat-Groveland Unified School District v. Superior Court of Tuolumne Court) which upheld the district's right to require that a claim be submitted using district procedures before a lawsuit may be filed. Regulation also updated to expand section on "Time Limitations."

BP 3515.21 Unmanned Aircraft Systems (Drones) - New optional policy addresses strategies for avoiding disruption and maintaining the safety, security, and privacy of individuals when the district grants permission for a person or entity to operate an unmanned aircraft system (drone) on or over district property. Policy reflects federal regulations and Federal Aviation Administration guidance, and provides that the district shall only grant permission if the planned activity supports the district's own instructional, co-curricular, extracurricular, or operational purposes.

BP 4140/4240/4340 Bargaining Units - Policy updated to reflect NEW COURT DECISION (Janus v. AFSCME) which held that public employees cannot be compelled to pay mandatory "fair share service fees" to an employee organization. Policy also reflects NEW LAW (SB 866, 2018) which prohibits districts from deterring or discouraging employees or job applicants from becoming or remaining members of an employee organization and prohibits sharing the date, time, and place of new employee orientations with anyone other than employees, the exclusive representative, or a vendor contracted to provide a service for the orientation. Policy deletes material regarding the employee organization's provision of a financial report, which is required by law to be submitted to the Public Employment Relations Board rather than the district board.

BB 9310 - Board Policies - Bylaw updated to address alignment of board policies with the district's vision, goals, and local control and accountability plan and add the concept of proactively addressing equity and equal access in board policies. Material rearranged to emphasize that policies are not operative if in conflict with applicable federal or state law or regulations or court decisions.
