Attract and retain an excellent, inspirational group of teachers, classified staff and administrators and support their development, hold them to high performance standards and assure that they have the resources to meet their objectives.

Discussion:

MLTA President Beal commented that they continue focus of students first, creating an environment that attracts and retains both students and staff. LCAP Clarification—We MLTA did not respond to the invitation to the LCAP as a burden or too much. We asked for a stipend for work beyond contract time which was denied by the district administration. In the past, the input has not been valued by the administration team (i.e., denied in letter format by the Superintendent (see LCAP letters on website). The process has a flaw as a team is to make decisions, not one person. The lack of appreciation, acknowledgement, or open thinking frustrated the staff as their time was given freely. It has been identified from the state that the LCAP Committee needs to have one certificated and one classified staff member on the team in order to ensure the discussed plan (adoption of

curriculum, working loads, and environments) follow the contract, or are bargained. We value teacher input as we are the ones on the front lines and greatly impacted by the decision of the LCAP. We will follow state recommendations and have a MLTA member serve on this committee with compensation from MLTA for sub time and a stipend. It is what is decide as a team that impacts the environment to attract and retain the students we are losing and the teachers we will need in the future.

CSEA #661 President Tucker and Secretary Grover commented that our CSEA chapter wants to support fire victims from Paradise. If any staff had family members affected, they are going to determine and give the family selected \$100.00 directly.
